- Criteria for acceptance:
 - » a recognized qualification of a Bachelor in Law or an equivalent qualification;
 - » proficiency in English.
- Application deadline is the 25th of August;
- Documents must be submitted to Ivan Franko National University of Lviv.

Tuition fee?

- 1 semester 949 \$ to Ivan Franko National University of Lviv;
- 2 semester 1500 € to Vilnius University;
- 3 semester 750 € to Vilnius University and 474,5 \$ to Ivan Franko National University of Lviv.
